## ASSAULT WITH INJURY-FAMILY VIOLENCE-CLASS A MISDEMEANOR

On March 19, 2016 at approximately 0746 hours, your Affiant was on duty as an Austin Police Officer wearing the uniform of my position with shoulder patches and badge on my chest. I was also driving a clearly marked Austin Police Department patrol unit equipped with emergency lights and the word "Police" on the vehicle.

ON THIS DATE AT APPROX. 0746 HOURS, MYSELF AND OFC M. JONES #6159, RESPONDED TO A DISTURBANCE WITH VIOLENCE CALL AT 1000 E 5<sup>TH</sup> ST (CORAZON APTS). THE TEXT OF THE CALL STATED A MALE AND FEMALE COUPLE WERE FIGHTING IN THE APARTMENT (APT) AND THEY WERE BREAKING THINGS INSIDE AND YELLING AND SCREAMING. UPON ARRIVAL, WE MET THE COMPLAINANT IN THE HALLWAY AND HE WAS IDENTIFIED AS; VU, LE. VU ADVISED HIS BUSINESS PARTNER/FRIEND AND HIS GIRLFRIEND WERE FIGHTING INSIDE THE APT. WE APPROACHED THE DOORWAY TO APT #564 AND WE COULD HEAR A LOT OF BANGING AROUND IN THE APT. IT WAS LOUD AND WE COULD HEAR YELLING AND SCREAMING INSIDE THE APT. THE OCCUPANTS OF THE APT WERE LATER IDENTIFIED AS; RODRIGUEZ, STEPHANIE AND PAUL QUI. VU ASKED QUI TO OPEN THE DOOR AND HE COMPLIED. QUI CAME OUTSIDE THE APT AND HE HAD BLOOD ALL OVER HIS FACE, ARMS, LEGS AND CLOTHING. QUI WAS WEARING BOXER SHORTS AND A WHITE TANK TOP. QUI WAS IMMEDIATELY HANDCUFFED UNTIL FURTHER INVESTIGATION. THERE WAS A FEMALE (RODRIGUEZ) INSIDE THE APT AND SHE WAS CRYING UNCONTROLLABLY ON THE COUCH AS SHE WAS CLUTCHING A SMALL CHILD. I OBSERVED THAT THE APT WAS IN COMPLETE DISARRAY AND FURNITURE AND GLASS WERE BROKEN AND OR TURNED OVER THROUGHOUT THE APT. I ALSO OBSERVED BLOOD SMEARED ON THE WALLS AND THE FLOOR THROUGHOUT THE APT. AFTER A FEW MINUTES OF ASSESSING THE SITUATION I WAS ABLE TO INTERVIEW RODRIGUEZ. RODRIGUEZ STATED SHE AND QUI HAVE BEEN DATING FOR 1 YEAR AND THEY HAVE BEEN LIVING TOGETHER FOR 8 MONTHS. RODRIGUEZ ADVISED QUI IS VERY CONTROLLING AND EXTREMELY JEALOUS. SHE STATED QUI HAD SOME FRIENDS OVER TONIGHT AND THEY WERE ALL INDULGING IN COCAINE, XANAX, MARIJUANA AND ALCOHOL. RODRIGUEZ ADVISED SHE HAD BEEN ASLEEP WITH HER SON WHEN QUI CAME HOME WITH HIS FRIENDS. SHE STATED OUI WANTED HER TO GET UP AND JOIN IN THE PARTYING. RODRIGUEZ STATED SHE GOT UP AND HAD A COUPLE DRINKS. RODRIGUEZ ADDED THAT QUI WAS INTOXICATED AND HE BECAME INCREASINGLY JEALOUS AND STARTED ACCUSING HIS FRIENDS OF FLIRTING WITH HER (RODRIGUEZ) AND INTICING HER INTO HAVING GROUP SEX. RODRIGUEZ ADVISED QUI FINALLY HAD ENOUGH AND KICKED ALL HIS FRIENDS OUT OF HIS APT. SHE STATED SHE, HER SON AND QUI WERE LEFT IN THE APT. RODRIGUEZ THEN STATED QUI BECAME ENRAGED AND STARTED KNOCKING OVER FURNITURE, SHELVES, TABLES AND BREAKING GLASS ALL OVER THE APT. RODRIGUEZ ADVISED SHE GATHERED A FEW OF HER THINGS AND TRIED TO EXIT THE APT WITH HER SON. RODRIGUEZ STATED SHE REACHED FOR THE DOOR HANDLE AS QUI STOOD IN FRONT OF THE DOOR AND BLOCKED HER FROM EXITING THE DOOR. RODRIGUEZ STATED QUI FORCIBLY PUSHED HER AND HER SON AWAY FROM THE DOOR WHICH WAS PREVENTING THEM FROM LEAVING. RODRIGUEZ STATED SHE TRIED SEVERAL TIMES TO EXIT THROUGH THE FRONT DOOR AND QUI CONTINUED TO BLOCK HER FROM EXITING BY FORCIBLY PUSHING HER AWAY FROM THE DOOR OR PUSHING HER ON TO THE FLOOR. THEN INTERVIEWED QUI AND HE ADVISED THAT HE BECAME ANGRY WITH RODRIGUEZ BECAUSE SHE WAS FLIRTING WITH HIS FRIENDS AND SHE WAS IN AGREEMENT TO HAVING GROUP SEX. QUI STATED HE DID KICK OUT ALL HIS FRIENDS AND HE AND RODRIGUEZ BEGAN ARGUING. QUI ADMITTED TO KNOCKING OVER OUT ALL HIS PRIENDS AND BREAKING GLASS THROUGHOUT THE APT. QUI ALSO ADMITTED TO NOT ALLOWING FURNITURE, TABLES AND BREAKING GLASS THROUGHOUT THE POLICE TO COME AND STREET FURNITURE, TABLES ALL DAMAGE HE WANTED THE POLICE TO COME AND SEE ALL THE DAMAGE DONE RODRIGUEZ TO LEAVE THE WANTED TO BE ABLE TO TELL HIS SIDE OF THE STORY WERE ALL THE DAMAGE DONE RODRIGUEZ TO LEAVE THE DAMAGE DONE IN THE APT.
