**RE: Restricted from Visiting HISD campuses**

Dear Ms. Terrell:

This letter serves as notice to you that your ability to visit Houston Independent School District (HISD) campuses and facilities will be restricted. This restriction is a result of your inappropriate conduct on January 16, 2025, at HISD headquarters located in the Hattie Mae White Building (HMW). Your conduct is egregious and violates HISD Board Policy DH (LOCAL) and FFH (LOCAL).

As stated above, on January 16, 2025, at approximately 10:20pm you started disrupting the HISD Board meeting that was being held. You were asked to stop yelling. When HISD PD officers asked you to leave, you refused. When officers tried to physically remove you from the premises, you dropped yourself on the ground and again refused to leave.

**Consequently, effective upon receipt, you are restricted from all HISD buildings and facilities until July 1, 2025. You are also prohibited from attending any HISD activities, meetings, or picking up HISD students for any reason on HISD property.**

HISD regrets having to take this action, however, the safety of our school community is our top priority and we must err on the side of caution when individuals threaten the safety of the learning environment. **Thus, you are hereby notified that your attempt to enter any HISD building or attend any activity or meeting you will be considered trespassing and you will be subject to arrest, as described in the official trespass warning below.**

**THIS IS AN OFFICIAL TRESPASS WARNING NOTICE.** Your presence on any campus or facility will be considered trespassing under Texas Education Code Section 31.107 and Texas Penal Code Section 30.05, which state in pertinent part:

**Texas Education Code Sec. 37.107, Trespass on School Grounds:** An unauthorized person who trespasses on the grounds of any school district of this state commits an offense. An offense under this section is a Class C misdemeanor.

**Texas Penal Code Sec. 30.05, Criminal Trespass:** A person commits an offense if he enters or remains on or in property of another... without effective consent and the person had notice that the entry was forbidden; or received notice to depart but failed to do so.

Please adhere to these expectations without exception unless you hear otherwise from me.
